#### NO ON PROP 131

Proposition 131 is an overly complicated, costly election proposal that is not a typical "ranked-choice voting" model and will not deliver on its promises. It would cost Colorado taxpayers \$21 million to implement over just the first two to three years. It's a scheme being funded and orchestrated by billionaires to tilt Colorado's election system in their favor by incentivizing more dark money in politics. The proposal creates a crowded field in which candidates with the most money will likely be able to cut through the noise and prevail.
